Notification Update

Re: Water Main Realignment Work Traffic Control Plan

Tansi,

On Oct. 11, 2024, a Door-To-Door Notification went out from Urban Systems Ltd. (our engineering consultant) regarding the Water Treatment Systems Improvement Project's Civil Construction Scope's Water Main Realignment along West Moberly Rd. of works being performed by S Young Enterprises (SYE) Ltd. that would have impacts on access to some WMFN driveways and subdivisions in October.

Original dates were as follows:

- Driveway Access #1 interrupted: October 11
- Misku Road Access/Driveway #2 Access: October 15-October 17
- Driveway Access #3: October 16-October 18
- Driveway Access #4: October 18-October 21
- Brown Road Access: Week of October 21

Temporary Impacts:

- Access to driveways will be temporarily impacted. Where possible, one access point per driveway will remain open at all times.
- A distance of five meters from the edge of road is required for the Contractor's equipment and installation of the watermain. Please ensure all personal vehicles and items within 5 meters of Moberly Road are moved prior to the watermain installation. We will provide a minimum of three days' notice if there are items to be moved in this area. If there are issues with moving vehicles or other personal items within this range, please let us know and we will coordinate a way of relocation.

- Access to Misku Road will not be possible for one day during this portion of the work. Efforts will be made to ensure that this crossing is completed as quickly as possible. We anticipate this impact will take place between October 15 and October 17, 2024.
- Access to Brown Road (west side) will be impacted during the later stage of this construction. Efforts will be made to ensure that this crossing is completed as quickly as possible. We anticipate this impact will be within the week of October 21, 2024.
- Water service – Contractor may have temporary shutoffs during the daytime hours. These shut offs are anticipated to last a maximum of 4 hours. Additional notices will be given in advance for impacted residents with an estimated time that water will be turned back on at minimum three days before a shut down.
- Water Shutoff – once all watermain is installed, there will be a day where water is shut off completely to connect the new system. Notice will be provided at minimum three days in advance of this shut off. This is currently expected to take place the week of November 4, 2024.
- Garbage and recycle pickup – garbage and recycle pickup may be impacted by driveway/road interruptions. If this is a concern for your single day disruption, please contact O&M to coordinate an alternate pick up.
- Deep utility construction will impact a part of the Moberly Road. There will be traffic control and signage to assist with navigation of Moberly Road during the installation of this water main. Please respect all traffic control personnel and signage.

Due to delays experienced on the Project, here is an **updated schedule of access interruptions at specified driveways or subdivisions over the next few weeks:**

- Driveway Access #1 (7779 West Moberly Rd.): **Completed**
- Misku Road Access/Driveway #2 Access: **Completed**
- Driveway Access #3: **October 24th & 25th**
- Driveway Access #4: **Cancelled as Map's satellite image is incorrect**
- Brown Rd Access: **Oct. 29th & 30th**

Notes:

- Speed reduction to 30km/hr. during construction (8AM-6PM Mon-Fri)
- Single Lane Traffic Only and Crew Working signs only when lane closures in effect

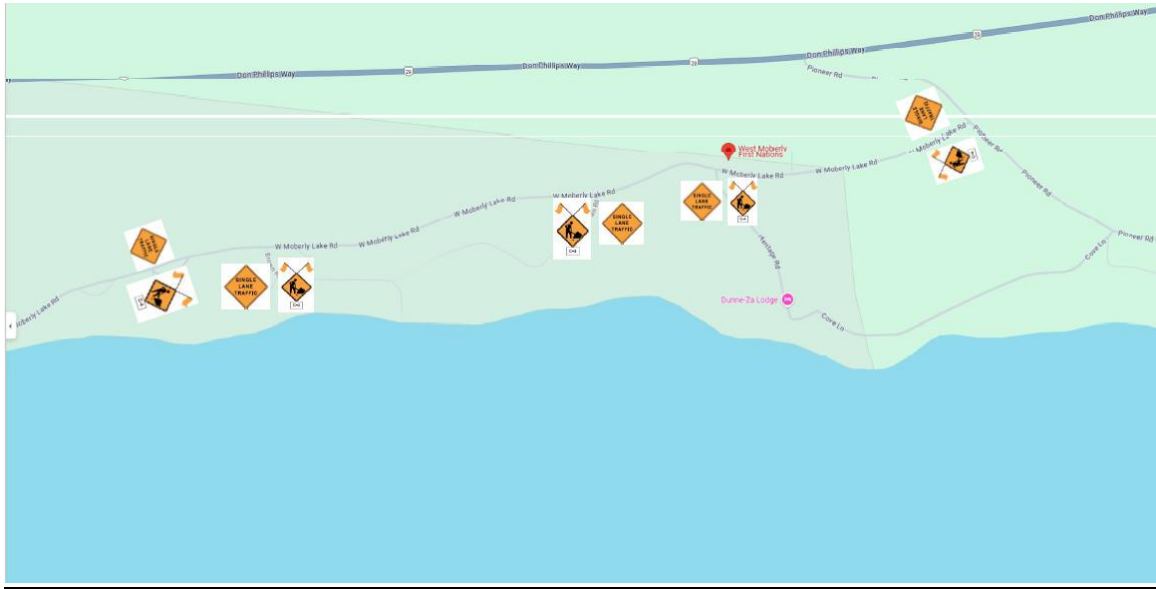
